Calendar, tuition, and fees are subject to change. You may petition to add after the deadline. Petitions to drop after the final drop deadline are not normally granted and require specific documentation. **Note: Nonattendance does not constitute an automatic drop.** If you are enrolled in a class and do not plan to attend that class, you must drop the course prior to the relevant deadline. (Faculty members have the right to drop you if you miss both of the first two class days of a semester or did not participate in an online class for the first week, but this action is not automatic.) If you are a registered student and receiving financial aid, you are authorizing the University to deduct all University debts from your current year's financial aid funds.

Fall 2011 Deadlines for 7-week courses that begin the 2nd half of the semester (starting approximately 10/24/2011):

Remember "drop" implies that you are still registered for another course. Disenrolling means you are not registered for any other course.

* Fee adjustments for dropping courses are based on total credit hours for the semester. Questions regarding refunds for courses scheduled in the 2nd half of the semester should be directed to Cashiers and Student Accounts.
